#### A. APPLICANT DESCRIPTION

- 1. Clayton Island Tours offers the 1000 Islands' most unique boat tour experience on our 43-65 passenger boats. This business provides family-oriented tours to get you closer to the islands and offer magnificent views of premier sights, such as giant Great Lakes freighters, lighthouses, magnificent island homes and the Thousand Islands International Bridge system up close. Daily stops to Boldt Castle and Rock Island Lighthouse are available. All tours have many photo opportunities and cruise areas of the 1000 Islands not seen on other tours. Four Boats providing Daily Tours and Charters departing 39611 Chateau Lane, Clayton, NY 13624 Also providing free parking.
- 2. Clayton Island Tours, LLC is recognized by the IRS as providing 'Island Boat Tours.' David L. Kay owns 100% of this business.
- 3. Not Applicable

#### B. PROJECT SITE INFORMATION AND FLOODING HISTORY/VULNERABILITY

- Currently, the bathroom facility is approximately 550 square feet. Located southward is the leach field
  which is approximately 75 feet. Located Northward is a waiting area for customers which is
  approximately 1,045 sq/ft. Also located north of the picnic area is the shoreline which is approximately
  110 linear feet and utilizes rip rap to stabilize the riverbank.
- 2. The 2019 Flood damaged the following:
  - Lawn
  - Fence
  - Docks
  - Shoreline
  - Boat Ramp
  - Dock Ramp
  - Leach Field
  - Bathroom Structure
- 3. Clayton Island Tours, LLC's project site is susceptible to future increased flood damage if left unchanged. The rip rap was taken back out into the river channel by the force of the floodwaters. The docking structure is continually destroyed by the wave action of the high-water event. The increased water level floods and erodes away the bathroom structure, the leach field, and the picnic area.
- 4. The above problems also occurred from the 2017 flood event. These challenges have lead to decreased business. Clayton Island Tours has to push back, or cancel, the start dates of boat tours because they have to make the docking location safe for clients by picking up debris, fixing the docks, stabilizing the shoreline, and obtaining port-a-potties when the bathroom facility floods or fails.
- 5. The owner, David Kay, has contacted the local, state, and federal authorities that govern the bed, banks, and shoreline of Lake Ontario. In 2019, he received a permit to install rip rap to help protect the shoreline. Unfortunately, the water level was over the rip rap and caused further unexpected damage to the business's property. Mr. Kay also has to bring in port-a-potties due to the bathroom facilities being flooded.
- 6. None known to current knowledge.
- 7. Clayton Island Tours, LLC's proposed project will stay within the existing footprint.
