Jefferson County Local Development Corporation Board Meeting Minutes May 6, 2021



The Jefferson County Local Development Corporation held their board meeting on Thursday, May 6, 2021 in the board room at 800 Starbuck Avenue, Watertown, NY and virtually via zoom.

I. Call to Order: Mr. Converse called the meeting to order at 8:01 a.m.

II. Pledge of Allegiance

III. Privilege of the Floor: Mr. Converse invited guests to speak. No one spoke.

- IV. Minutes: Minutes of the regular meeting held April 1, 2021 were presented. A motion to approve the minutes as presented was made by Mr. Warneck, seconded by Ms. Powers. All in favor. Carried.
- V. Treasurer's Report: Mr. Aliasso reviewed the financials for the period ending April 30, 2021. Mr. Aliasso asked Mr. Eaton if the LCO Destiny loan principal moratorium is over and if they are current. Mr. Eaton said that he will have to check the file. During review of the check register, Mr. Aliasso asked if check number 5535 labeled as Watertown LOC is for Watertown Local Development Corporation. Mr. Eaton said yes. Mr. Aliasso asked what check number 5552 to County of Lewis was for. Ms. Sampson said it was our portion for the snowmobile study. A motion was made by Mr. Aliasso to accept the financial report as presented, seconded by Mr. Jennings. All in favor. Carried.

VI. Committee Reports:

a. Alternative Energy Committee – Mr. Warneck gave the report on behalf of Mr. Johnson. He said that the committee held a joint meeting with the JCIDA Loan Review Committee. He said they reviewed an application for a proposed community solar project in Brownville and discussed incentivizing or disincentivizing the use of prime farmland for solar projects, whether community or utility size projects. Mr. Zembiec said that while some counties are choosing to incentivize (discount), the disincentivizing will add a premium cost to the develop if they choose to use prime farmland since developers are already paying the \$5,500/MW base rate willingly. Mr. Warneck said the IDA board will discuss the UTEP at the IDA meeting later today.

b. Building and Grounds Committee – Mr. Burto said there is nothing new to report. Mr. Zembiec said the YMCA project is proceeding on schedule. He said construction will start in August.

VII. Council Reports:

- a. Ag Mr. Matteson said that he continues to work on some small projects. He said that the dairy parade/campaign has reached the \$10,000 fundraising goal and will begin filming this weekend for the video. He said that the parade will be livestreamed by NBC Watertown.
 - Mr. Matteson indicated that he is working with the Watertown Rapids to setup an agricultural day at one of their home games, most likely at the end of June.
- b. Manufacturing Mr. Zembiec said that he spread the word that Timeless Frames was holding a walk-in vaccine clinic. He reported that MetalCraft Marine received a federal grant that our organization supported for new manufacturing equipment. He said that grants were made by the Northern New York Community Foundation to some of the workforce partners (BOCES and WPBS) that are working to spread awareness of trade and manufacturing careers.
- c. Marketing Mr. Weir said that he continues to work with the REDI Program. He indicated that there are still many cubicles available at the 146 Arsenal Street building that need to be removed by the end of the month. He said that they are now being offered to more than just not-for-profits. Mr. Weir said that the new website looks good and is working great. He reported that Cheryl Mayforth spoke about workforce on this week's radio spot.

Craig Fox joined the meeting at 8:20 a.m.

VIII. Unfinished Business:

1. **Deferiet Site** – Mr. Zembiec reported that NYSERDA visited the former paper mill site to gather information and assess its sustainability for solar development, and for inclusion on its list of 'Build Ready' sites.

Matthew Moses, Esq. joined the meeting at 8:22 a.m.

IX. Counsel: None.

X. New Business:

1. Resolution No. 05.06.2021.01 to support childcare training and the establishment of new regulated home day care facilities in Jefferson and Lewis Counties – Mr. Zembiec said that the lack of childcare has been recognized as a challenge for years. He said that a 2020 survey concluded that it was a top concern for employers. Mr. Zembiec said that he gives credit to Lewis County for putting together the program since home based childcare is a great need at this time. He said that we will also be helping to create businesses during the process.

It was noted that the resolution should reflect the total cost of \$45,460, not \$45,450. A motion was made by Mr. Gardner to approve the amended resolution, seconded by Mr. Aliasso. All in favor. Carried.

RESOLUTION TO SUPPORT CHILDCARE TRAINING AND THE ESTABLISHMENT OF NEW REGULATED HOME DAY CARE FACILITIES IN JEFFERSON AND LEWIS COUNTIES

WHEREAS, a 2019 report by the Childcare Coordinating Council of the North Country identified 86% of North Country census tracts as childcare deserts, with inadequate childcare to meet local needs; and

WHEREAS, in Jefferson County, there are 6.7 children for each regulated childcare slot available, and 100% of the county is considered a childcare desert; and

WHEREAS, the lack of affordable childcare is an impediment to many people entering the workforce; and

WHEREAS, a 2020 survey of businesses across the 7-county North Country region, identified childcare as a top priority by employers, who indicated this was a pre-COVID issue impeding recruitment efforts and affecting employee attendance, and that it was exacerbated by the pandemic; and

WHEREAS, in addition to addressing a community need and workforce issue, the establishment of regulated home-based day care facilities will increase the number of locally-owned small businesses; now therefore be it

RESOLVED, that the Jefferson County Local Development Corporation (JCLDC) agrees to join with Lewis County Economic Development in a proposal they have developed in partnership with the Community Action Planning Council, Jefferson Community College, the Small Business Development Center, and Lewis County Planning Department to support the *North Country Regulated Home Day Care Training Bootcamp*; and be it further

RESOLVED, that the JCLDC will pay \$24,230 for its portion of the \$45,460 total cost to administer this program in its first year of operation; and be it further

RESOLVED, that the Chairman, Vice Chairman, Secretary, and/or Chief Executive Officer are authorized and directed to execute any and all documents necessary to carry out the purposes of this Resolution.

This resolution shall take effect immediately.

Joint Meeting of JCIDA Loan Review and JCLDC Alternative Energy Committee Meeting Minutes May 18, 2021

I. Call to Order: Loan Review Chair Aliasso called the meeting to order at 8:01 a.m.

II. Pledge of Allegiance

III. Other/Unfinished Business:

1. **Draft UTEP** – Mr. Aliasso said that Mr. Zembiec sent out the most recent draft of the UTEP for the joint committee to review. He said that each section will be reviewed today.

Mr. Zembiec said that he used an introduction that is easier to read and follow. He said that he rearranged some of the subsections so that the abatement descriptions are grouped together an come after the introduction, followed by the process.

Mr. Aliasso suggested changing the rated capacity of less than 25 megawatts to 20 megawatts in Section A. Real Property Tax Abatements, subsection 2) Renewable Energy Projects. Mr. Warneck commented that he does not think that we should reference the Office of Renewable Energy Siting (ORES) and pointed out that anything above the 20 megawatts will be a deviation. Mr. Zembiec said that according to ORES, projects 25MW and greater are mandated to go through their siting process. A developer with a project between 20 – 25 megawatts can opt in. Mr. Warneck asked if we have the authority to qualify a project as a deviation if we are uncomfortable with it, which would leave the decision to the taxing jurisdictions. Mr. Zembiec said that he will check with Attorney Miller.

Mr. Zembiec pointed out that #15 under the Evaluation Criteria states that 'any other pertinent reasons deemed relevant by the Agency provided said reasons are set further in writing'. He said that it will be simpler to change the megawatt threshold rather than tie our UTEP to an outside organization's process, such as ORES.

After discussion, committee members agreed to change the megawatt threshold to under 20.

Mr. Jennings asked if there is any concern that we are leaning more towards solar than wind. Mr. Zembiec said that he used the term 'renewable energy projects' which covers all categories such as solar, wind, hydro, etc. He said that he will add the categories in parenthesis after the renewable energy project title.

Mr. Warneck asked if we should keep a fixed PILOT term or have flexibility for renewable projects. Committee decided not to make a change.

Mr. Aliasso reviewed the Deviations section. He suggested adding 'as determined by the Agency' in the first sentence before the 'shall be treated as a deviation' wording. Mr. Zembiec said that he will confirm the change with Attorney Miller.

Mr. Zembiec asked if we want to keep the practice of seeking approval from the affected taxing jurisdictions (ATJ's) when there is a deviation. He said that we are one of two IDA's that choose this approval method since we are only obligated by state law to notify the ATJ's of the negotiated terms. He noted that it adds time to the process and forces the ATJ's to make a decision even though some of them don't want the responsibility. Committee members did not make a change to the original language.

Mr. Aliasso reviewed Section F. PILOT Agreement and Approval Process. He said that #7 addresses local labor but wondered if it should be added to the evaluation criteria. It was noted that it is covered in #4 of the evaluation criteria and is certified in the Application. Mr. Converse asked if we will be asking for certified payrolls. Mr. Warneck said that the requirement of certified payroll can be addressed in the Project Agreement. Mr. Zembiec said that he is working to update the Application to add language for local labor provisions.

Mr. Zembiec said that he will make the changes suggested today and send them to Attorney Miller for review and comment. He said that once he receives signoff from Attorney Miller then he will send it out to all board members and will put it on the June board meeting agenda. He said after the board meeting, the revised UTEP will be sent out to all Jefferson County taxing jurisdictions for review and comment (90-day period before final approval by the board). Mr. Zembiec said that he will update the Application during this time.

Other -

Mr. Zembiec asked how the committee wants to handle large scale projects even though we haven't received an application. Mr. Aliasso said that the Energy Committee can start discussions. Mr. Warneck said that another meeting should be scheduled to talk about Mr. Matteson's concept for protecting agricultural land.

Mr. Johnson asked if anyone has heard about the State's uniform appraisal. Mr. Zembiec said not yet.

Mr. Warneck noted that he spoke with Katie Malinowski about scheduling a workshop with John Zukowski for local elected officials and assessors on solar project assessments. Mr. Zembiec agreed this is a good idea and will follow up with Ms. Malinowski.

IV. Adjournment: Mr. Aliasso adjourned the joint meeting at 9:00 a.m.
